## II. Practical Animal Experiment MODULE

The practical part has to be imparted in the institutes' own labs. It will be completed by an exam conducted by an animal welfare officer. In parallel with the theoretical part, candidates are introduced by their working group into the practical part of laboratory animal science and into the concrete projects, they will participate in. After passing the theoretical part and being introduced completely into all relevant fields of activity, please inform the animal welfare officer and arrange an examination date for the practical part.

Please have your supervising tutor confirm your assistance and practical introduction into the various interventions and manipulations using the table below (Annex 3).

This table has to be presented to the animal welfare officer before the practical exam. The entries should be in accordance with the "Tierschutzversuchstierverordnung (Anlage 1 Abschnitt 3)". During the practical exam, especially the yellow marked points will be relevant (points 3, 4, 6, 7, 8, 11, 13, 14).

According to §16 passage 1 sentences 1 and 2 of the Tierschutzversuchstierverordnung (TierSchVersV) animal experiments with vertebrates and cephalopods may only be planned and/or executed by persons, that possess the knowledge and skills according to annex 1 chapter 3 TierSchVersV.

All techniques should be imparted by the working group. If there are special interventions, that are not performed by the own group, other working groups can be asked to show them. For the points marked with \*), an introduction at the animal welfare officer's facility is possible.
